It is proposed to fill up this vacancy by appointing suitable officers from the grade of Supdts of Central Excise, Service Tax & Customs.


The selected officers, while working in the Directorate General in the grade of Senior Intelligence Officer on deputation basis, will be entitled for Special Allowance as admissible. Normally, the deputation is for a period of five years, subject to the willingness of the officer, his/her performance, concurrence of his parent Commissionerate and approval of the competent authority.

It is requested that the circular may please be brought to the notice of all the formations under your jurisdiction and the applications of willing officers be forwarded to this office. While forwarding the names of the willing officers, the following information may also be sent for evaluation by this Directorate.

1. Complete bio-data and willingness of the officer alongwith history of postings
2. ACR/APAR gradings for the last 5 years (duly verified and attested by the Addl./Joint Commissioner (P&V).
3. Vigilance Clearance; and
4. 'No objection' from the Cadre Controlling Authority to relieve the officer in the event of his selection.

The above information/details may kindly be arranged to be furnished to this Directorate General by **12/05/2017**.
