Sub: Promotion to the grade of Superintendent – Reg.

Consequent to Annual DPC for the year 2016-17 held on 12.01.2017, the following Inspectors of GST & Central Excise are promoted *on Ad-hoc basis* to the grade of Superintendent of GST & Central Excise, in the pay Matrix at the Level - 8 (Rs.9,300-34,800 with GP-Rs.4,800 in 6th Pay Commission) as per 7th Pay Commission recommendations, on notional basis with effect from the date mentioned against their respective names and on an in-situ basis.

02 Shri R Chinnadurai will be placed below Shri A Ganesan (Emp Code – 5032) and above Shri M Aaron (Emp Code-2832) in the Seniority list of Superintendents. Shri Job Jacob will be placed below Shri S Shanmugakani (Emp Code-2155) and above Shri T Krishnamoorthy (Emp Code-5953) in the Seniority list of Superintendents.

03. The officers promoted on Adhoc basis are not entitled to exercise option for fixation of pay and the promotion does not confer on the officer so promoted any claim for continued officiating in the grade of Superintendent of GST & Central Excise and the period of such service will not be counted for seniority or as qualifying service for further promotions.

04. The promotion now ordered is subject to outcome of the following cases.

(i) Review of DPC in respect of Promotion Order No. 260/97 dated 29.08.1997 in the grade of Superintendent based on pending clarification / decision from DOPT / Hon'ble Supreme Court.

(ii) Writ Petition in W.P.C.T. 261/2008 filed by Shri Samiran Roy & Others pending before the Hon'ble High Court, Calcutta.

(iii) SLP pending before the Hon'ble Supreme Court against the Hon'ble A.P High Court order dated 07-03-2005 in Writ petition No. 2378/2005 filed by Shri S.S.L.Narayana and WP No. 45/2005 filed by Shri. Giridhar Prasad and others, as mentioned in the Board's letter F. No. A.32022/70/2003 AD-III A dated 26.09.2005. Therefore, the promotion of these officers to the grade of Supdt is also subject to the outcome of above SLP.

(iv) Outcome of subsequent review of promotions in the grade of Inspector consequent to review of promotions in other feeder cadres.

(v) Other cases, if any, pending before any judicial fora.

05. The promotion now issued is subject to the condition that the officers concerned should join latest by 03.04.2018 failing which it will be treated that they have not accepted the promotion *ab initio* and all consequences arising as a result of non-acceptance of promotion shall follow.

06. Further, the Commissioner concerned shall ensure that if the Inspector whose name figuring in this promotion order is under suspension or facing any Disciplinary proceedings or prosecution or under penalty period, such officer should not be allowed to assume charge as Superintendent. This fact may be brought to the notice of the Cadre Control Authority immediately.

07. The compliance report about the joining/non-joining of the officer should be sent to this office by the concerned Commissionerate by 05.04.2018.

08. This order is issued with the approval of the Competent Authority, Cadre Control, Tamil Nadu and Puducherry.
