  - (c) No advance shall be paid and payment will be made only on completion g of the work.;
  - (d) The envelope containing the quotation should be super scribed as, QUOTATION FOR "FIXING OF WALL TILES & FLOOR TILES IN TOILETS GROUND FLOOR/ AT MAIN BUILDING" and should be addressed to the Additional Commissioner of GST of Central Excise, Chennai North Commissionerate, Chennai-34. The quotation should be submitted in a sealed cover and should reach the undersigned on or before M/03/2018 by 15.00 hrs.
