The Principal Commissioner of GST and Central Excise, Chennai North Commissionerate, Chennai 600 034, plans to renovate/repair in the Room Nos.301 & 302 in the Office at the Main Buildings, 26/1, Mahatma Gandhi Road, Nungambakkam, Chennai-34.

- 1. Interested parties possessing the requirements as under may submit their quote to undertake the below mentioned work.
- 2. Interested parties may please visit and download the tender details from the Official Website <a href="www.kalalchennai.gov.in">www.kalalchennai.gov.in</a> and may inspect the premises on any working day after consultation with the Deputy Commissioner (Preventive) at Nungambakkam under intimation to the Deputy Commissioner (Prev.) of GST and CX, Chennai North Commissionerate, Chennai 600 034.
- 3. The quote should be for the below mentioned work.

Sl.No	Description of work	Room No.
1.	Electrical wiring / supply & fixing of concealed 2'x2' LED electrical light fixtures-2 Nos. and also removing the old unusable wires (electrical, telephone and data) and plastic tube and concealing all cables & wires. Providing wiring for LED light fixtures 2 run of 1.5 sq. mm wire (of Standard make)	
2.	New concealed wiring for 1 No. Air Conditioner with 2 run of 4 sq.mm with 1 run of 2.5 sq.mm with metal box and socket	201 202
3.	Supply & fixing of False Ceiling with 12.5 mm thick gypsum board confirming to IS: 2095-Part I but excluding cost of painting.	301,302
4.	Removing existing wall paint by scrapping, surface preparation, applying white cement based putty of average 1 mm thickness to prepare the surface even and smooth. Apply one coat of water thinnable cement primer. Two coats of acrylic emulsion paint of standard brand on wall/ false ceiling surface.	
5.	Supply and laying of vitrified floor tiles 600 mm x 600 mm dimension. The thickness shall be	

specified by the manufacturer but not less than 8 mm. The screed bed for laying the tiles shall be of cement and sand mortar, and shall not be less than 10 mm at any place. (600 sq.ft.)

1. Interested parties should possess the following eligibility criteria.

- (a) They should be registered with GST and should possess a PAN number and have a minimum of 10 years experience in similar nature of work; copies of GST Registration, PAN card and documents in support of work experience should be enclosed with the quotation.
- (b) They should have undertaken similar work for Central / State Govt. for a minimum period of 10 years and should have executed at least one single order for a value of more than Rs.15 Lakhs. Work completion certificates to be enclosed to the quotation, as proof.
- (c) No advance shall be paid and payment will be made only on completion of the work.;
- (d) The envelope containing the quotation should be super scribed as, QUOTATION FOR "PROVISION OF ELECTRICAL/FALSE CEILING/PAINTING IN ROOM NO.301 & 302 MAIN BUILDING" and should be addressed to the Additional Commissioner of GST of Central Excise, Chennai North Commissionerate, Chennai-34. The quotation should be submitted in a sealed cover and should reach the undersigned on or before

22/03/2018 by 15.00 hrs.

- 2. The sealed quotation will be opened at 16.00 hrs on the same day. The intending firm who would be allotted the tender must be in a position to complete the work within 15 days from the date of receipt of the work order.
- 3. The Principal Commissioner of GST & Central Excise, Chennai North Commissionerate has the power to accept / reject any tender without assigning any reason whatsoever and his decision will be final.
