- 02. The candidates should report for duty at the above mentioned office on or before **26/07/2019**, failing which this offer of appointment will stand automatically cancelled.
- 03. No travelling or any other allowance will be admissible to the candidate for joining at the place of posting.
- 04. The candidates should produce all the certificates in original regarding the Date of Birth, Educational Qualification, Community, etc., at the time of reporting for duty.
- 05. The candidates will be on probation for two years from date of appointment.
- 06. The seniority of the candidates in the grade of Executive Assistant will be fixed as per the orders in force.

- 07. With regard to Leave, Travelling Allowances and all other matters connected with service conditions, the candidates will be governed by the rules and orders in force from time to time and applicable to the branch of public service to which they may belong.
- 08. The candidates will be liable to be posted and transferred anywhere in Tamil Nadu and Pondicherry within the Cadre Control jurisdiction of the Cadre Control Authority, Chennai Zone.
- 09. The candidates shall not indulge in activities not officially organized or in any manner considered as indiscipline.
- 10. For appointment to posts under the Central Government servants and others, Central Government employee and permanent/provisionally permanent State Government employees will be entitled to joining time under these rules. But temporary employees of the Central Government who have not completed 3 years of regular continuous service entitled to joining time would not be entitled to joining time pay.
- 11. If the candidates are already employed, the officers should produce proper relief report from the employer concerned after fulfilment of formalities contained in Rule 26(2) of C(Pension) Rules, 1972 read with the instructions contained in M.F. O.M No.F.3(6)-E, V(a)/71, dated 04.12.1972.
