2	Notification No 37/2019-central Tax dated 21.8.19	Act 2017 read with sub rule 5 of rule 61 of CGST Rules 2017, the commissioner on the recommendation of the council hereby amends Notification No 29/2019 central tax dated 28.6.19 by inserting a proviso in the first paragraph	
3	Notification No 04/2019 Central Excise NT dated 21.8.19	Central Government hereby appoints 1 <sup>st</sup> September 2019 as the date on which Sabka Vishwas (Legacy Dispute Resolution) 2019 comes in to force.	
4	Notification No 05/2019 Central Excise NT dated 21.8.19	In exercise of powers conferred by Sub section 1 & 2 of section 132 of Finance (No 2) Act 2019 (23 of 2019), the Central Government hereby makes <b>Sabka Vishwas (Legacy Dispute Resolution) Scheme Rules 2019</b> , which shall come in to force on 1 <sup>st</sup> day of September 2019.	

With respect to constitution of the "designated committee" as required under sub Rule 5(2) of Sabka Vishwas (Legacy Dispute Resolution) scheme Rules 2019, it is informed that the jurisdictional officers of the Commissionerate will form the "designated committee" under clause 5 1(a) for the cases where the tax dues are more than rupees fifty lakhs i.e jurisdictional Commissioner & jurisdictional Additional Commissioner/Joint Commissioner & for clause 5 1(b), for the cases where the tax dues are rupees fifty lakhs or less (Jurisdictional Additional Commissioner/Joint Commissioner Deputy/Assistant and commissioner) as detailed in the Annexure attached to this Trade Notice .
