
Reply to Point No.1 : Copy of the Board's letter is enclosed which is self-explanatory.

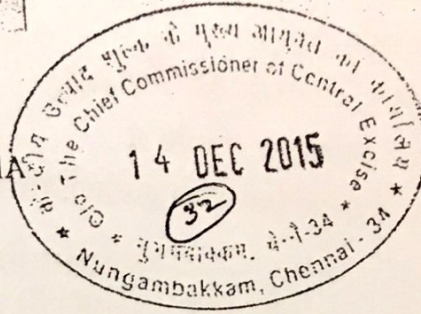


