 Sub: Promotion on notional basis to the grade of Inspector for the vacancy year 1991-92
 – in respect of Shri. T. Thirunavukkarasan.

A DPC was held on 13.09.2019 to review the Review DPC held on 27.02.1998 for the years 1988-89 to 1997-98 to consider Shri. T. Thirunavukkarasan for according notional promotion in the grade of Inspector against the vacancy year 1991-92. The Review DPC was held as per Board's letter F.No. A-32022/18/2013-Ad.III.A dated 29.04.2019 informing that the proposal for implementation of the CAT, Madras Order dated 12.04.2016 in O.A No. 382/2013 filed by Shri. T. Thirunavukkarasan, was accepted and to take further necessary action, for re-fixation of the seniority of the applicant in the grade of Inspector above his juniors Shri. S. Duraichamy and Smt. S.A Sarada in the Seniority Lists.

02. Accordingly, the DPC decided to empanel Shri. T. Thirunavukkarasan, in the select panel against the vacancy year 1991-92 above Shri. S. Duraichamy who was empanelled for promotion for the vacancy year 1991-92 in terms in terms of para 5(i) of the Board's letter F.No. 1/1/62-Ad.III A dated 27.09.1965. The Seniority of Shri. T. Thirunavukkarasan is re-fixed as given hereunder in the Seniority lists pertaining to the corresponding years.
