**Subject: Preventive measures to contain the spread of Novel Corona virus (COVID-19) – Revised Attendance of Central Government officials – reg.**

Please refer to DOPT O.M. F.No.11013/9/2014-Estt.A-III dated 19.04.2021 and 06.05.2021 issued by Additional Secretary, Govt. of India, New Delhi read with MHA Order No.40-3/2020-DM-I(A) dated 29.04.2021 on the above subject read with G.O(MS)371 dated 09.05.2021 issued by Revenue and Disaster Management( DM-IV) Government of Tamilnadu.

2. In connection with the complete lockdown announced by the Government of Tamilnadu with certain exceptions, the duty roster, along with staggered timings, for Group 'B' & 'C' officers posted in Headquarters for the period from **11.05.2021 to 31.05.2021** is enclosed in Annexure- I, where **Green colour indicates "to attend office" and Red colour indicates "to work from home"**. The officers, who avail the facility of 'Work from Home', should strictly adhere to the following conditions:

- i. "Work from Home" should not be clubbed / availed along with any kind of leave (EL / CL etc.)
- ii. They must stay at Home.
- iii. They should not leave Station / Headquarters (Chennai) during the period of Work from Home.
- iv. They must be available on Telephone and Electronic means of communication at all times.
- v. They should reach office, if called for any exigency of work, at short notice.

3. Further, pregnant women officers / staff are required to submit their willingness to their Reporting Officer, if they would like to 'Work from Home'.


4. All Group A officers should attend office on all days and no leave will be sanctioned unless it is a medical or family emergency.
