1.	10 Meter Air Rifle	This would be a 40 shot match, 15 Minutes for unlimited sighters and 50 minutes for the match. Scoring would be in decimals. (Match No 01)
2.	50 Meter Rifle Prone	This would be a 30 shot Match, 15 Minutes for the sighters (10 shots) and 25 minutes for the match. Scoring would be in decimals.(Match No 02)
3.	10 Meter Air Pistol	This would be a 40 shot match, 15 Minutes for unlimited sighters and 50 minutes for the match.(Match No 03)
4.	50 Meter Free Pistol	This would be a 30 shot Match, 15 Minutes for the sighters (10 shots) and 25 minutes for the match (Match No 04)
5.	25 Meter Standard Pistol	This would be a 30 shot Match, 1 series sighters ( 5 shots) and 25 minutes for the match (Match No 05)
6.	25 Meter Sports Pistol	This would be a 30 shot Match, 1 Series sighters (5 shots) and 30 minutes for the match (Match No 06)
7.	25 Meter Centre Fire Pistol	This would be a 30 shot Match, 15 Precision shots and 15 duelling shots. 5 sighter shots before precision and duelling shots. Match duration would be 30 minutes. (Match No 07)
8.	Single Trap 15 shot match	40 minutes match and training.

The participants would need to carry their own weapons. In case they do not have a weapon, it may be rented from the Shooting Range, subject to availability at the Range. Ammunition shall be provided on payment basis at the Shooting Range for the competition. The participant shall be responsible to collect the ammunition from the facility manager and submit the empty cartridges after the end of the match.

Further, all the participants wishing to participate in this tournament needs to fill up the enclosed registration form for the CRSCB Shooting tournament and submit the same by 24.02.2020 positively at the address as mentioned in the registration form so as to enable the organizer to determine the exact championship duration, match schedule and requirement of total ammunition as the same requires to be arranged well in advance.
