Reply to Point No. 1 : The information sought is of confidential nature. It is informed that the note sheets and minutes of DPC are exempt from disclosure under Section 8(1)(e) & 8(1)(j) of RTI Act, 2005.

Reply to Point No. 2 : ST Category vacancy for Annual DPC 2019 is 88 and for Annual DPC 2020 is 81.

Reply to Point No. 3 : The information sought for is vague and unclear. Hence, as per Section 2(f) of RTI Act, 2005, information available in any material form can only be furnished. As far as this point is concerned, information as required could not be furnished in terms of DOPT O.M.No.1/18/2011-IR dated 16.09.2011 in as much as the public authority is not required to furnish the information which require drawing of inferences or making of assumptions.


