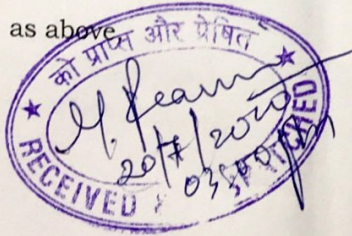
Due to pandemic COVID-19 and ensuing lockdown, this office was not in a position to reply within 30days as stipulated in the RTI Act, 2005.
