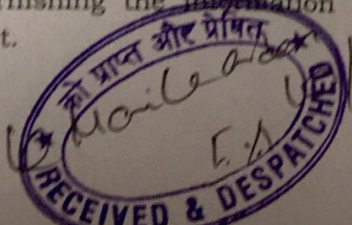

The reply to your RTI application in respect of this office is furnished here under:

Reply to Point No. 1 : No of cases against Group B Govt. employees of CBIC registered in all vigilance zones (and HQ, if any) from 01.04.2018 to 31.03.2020 (including both the dates) = 7.

Reply to Point No. 2 : No. of cases (from among those in Point No. 1) where the statutory time period of 6 months for departmental inquiry completion is over as on 01.10.2020 = 3.

Reply to Point No. 3 : No. of cases (from among those in Point No. 2) wherein the departmental inquiry was not submitted within a period of 6 months as mandated by the statutory rule = 3.

Reply to Point No. 4 : No. of cases where due to non-observance of the statutory rule, action was taken against the inquiry officer of vigilance in compliance with para 3 of F.No. C-14011/07/2016-Ad-V/8702 dated 11.07.2018 = Nil.
