Sub: Promotion to the grade of Superintendent – Reg.

Consequent to the Annual DPC for the year 2020 held on 30.12.2019, the following Inspectors of GST & Central Excise are promoted on Regular Basis to the grade of Superintendent of GST & Central Excise in the pay Matrix at the Level-8 as per 7th Pay Commission with effect from 01.02.2020. The officers shall assume charge as Superintendent on or after 01.02.2020 in their nominated place of posting. The promotion now ordered will be effective from the date the promoted officers assume charge as Superintendent in their nominated place of posting.

02. The Seniority of the officers will be fixed as per the orders in force.
03. The officers should exercise their option for fixation of pay in terms of F.R.221(a)(i) within one month from the date of joining as Superintendent. The officers who have already been granted Financial upgradation under Assured Career Progression Scheme / Modified Assured Career Progression Scheme are not entitled for pay fixation benefits now.
04. The promotion now ordered is subject to outcome of the followings.
 - (i) Writ Petition in W.P.C.T. 261/2008 filed by Shri Samiran Roy & Others pending before the Hon'ble High Court, Calcutta in terms of Board's letter F.No.C-18012/6/2009 Ad IIB dated 16.09.2010.

- (ii) SLP pending before the Hon'ble Supreme Court against the Hon'ble A.P High Court order dated 07-03-2005 in Writ petition No. 2378/2005 filed by Shri S.S.L.Narayana and WP No. 45/2005 filed by Shri. Giridhar Prasad and others, as mentioned in the Board's letter F. No. A.32022/70/2003 AD-III A dated 26.09.2005. Therefore, the promotion of this officer to the grade of Superintendent is also subject to the outcome of above SLP.
- (iii) Other cases, if any, pending before any judicial fora.

05. Further, the Commissioner concerned shall ensure that if the Inspector whose name figuring in this promotion order is under suspension or facing any Disciplinary proceedings or prosecution or under penalty period, such officer should not be relieved or allowed to assume charge as Superintendent. This fact may be brought to the notice of the Cadre Control Authority immediately.

06. The promotion now issued is subject to the condition that the officers concerned join latest by 17.02.2020 in their nominated place of posting failing which it will be treated that they have not accepted the promotion *ab initio* and all consequences arising as a result of non-acceptance of promotion shall follow.

07. The promotion of officers to the grade of Superintendent who are currently on deputation, shall take effect only after they are repatriated and report to the nominated place of posting for joining the promotional post.

08. The compliance report about the joining/non-joining of the officers should be sent to this office by the concerned Commissionerate by 20.02.2020.
