

MINUTES OF THE MEETING BETWEEN THE CHIEF COMMISSIONER OF CUSTOMS (PREVENTIVE) ZONE, TRICHY AND THE CHIEF COMMISSIONER OF CUSTOMS & GST & CENTRAL EXCISE, CHENNAI AND HELD VIRTUALLY ON 12.08.2021 TO ROTATE DEPUTY/ ASSISTANT COMMISSIONERS BETWEEN GST ZONE, TAMILNADU & PUDUCHERRY AND CUSTOMS PREVENTIVE ZONE, TRICHY.

As per Para 3.2.1 and 3.2.2 of the transfer/placement guidelines, 2018 for Group "A" Officers of the Indian Revenue Service (C&CE), the Officers will, as far as possible, be rotated between the Customs and GST branches every 2-3 years. At stations where there are separate Principal Chief Commissioners / Chief Commissioners of Customs and GST, a Committee of all such Chief Commissioners shall collectively decide on the rotation between Customs and GST & CX Zones. Normally, this shall be done after the Annual General Transfers have been effected.

02. In view of the above, a Meeting was held virtually on 12.08.2021 between Dr. Uma Shanker, Chief Commissioner of Customs (Preventive) Zone, Trichy and Shri. M V S Choudary, Chief Commissioner of Customs, Chennai Zone & Chennai GST Zone for rotation of Deputy/ Assistant Commissioner between CCP Zone, Trichy and GST & Central Excise Zone, Chennai.

03. As per Order No.82 & 85/2021 dated 15-07-2021 and 19-07-2021, 20 Officers have been transferred out of Chennai GST & Central Excise Zone and 27 officers have been posted to Chennai GST Zone. 04 officers have been transferred out of CCP Zone, Trichy and no officer has been posted to CCP Zone, Trichy. As per this office order No.73/2021 dated 04.08.2021, 04 officers were posted to CCP Zone, Trichy.

04. After sharing of officers among Chennai GST Zone, Chennai Customs Zone and CCP Zone, Trichy, the sanctioned strength, working strength and vacancy position in the grade of AC/ DC in both Zones is as follows:-

05. The officers who had completed 3 years of service in the zones and requested for change of zones were considered for rotation between the zones. 02 officers completed 03 years of service in CCP Zone, Trichy, viz. Shri. M Pandaram, AC, and Shri. Paul Peter W, AC, have requested for Chennai GST Zone postings and 01 officer completed 03 years of service in Chennai GST Zone, viz. Shri. N Pandiyaraj, DC, has requested for CCP Zone Trichy postings.

In view of the above and in order to maintain the present vacancy position in both zones, it has been decided to rotate 01 AC/DC from Customs (Preventive) Zone, Trichy to GST & CX Zone and 01 AC/DC from GST & CX Zone to Customs (Preventive) Zone, Trichy keeping in view of the request made by these officers for justifiable reasons.

07. Accordingly, it has been decided to rotate/transfer the below mentioned Officers between GST & Central Excise Zone and Customs (Preventive) Zone, Trichy.
