MINUTES OF THE MEETING OF THE CHIEF COMMISSIONER OF GST & CENTRAL EXCISE, CHENNAI AND THE CHIEF COMMISSIONER OF CUSTOMS, CHENNAI HELD ON 15<sup>TH</sup> DECEMBER 2020 AT THE CONFERENCE HALL IN THE OFFICE OF THE PRINCIPAL CHIEF COMMISSIONER OF GST & CENTRAL EXCISE CHENNAI TO ROTATE DEPUTY / ASSISTANT COMMISSIONERS BETWEEN GST ZONE, TAMILDADU & PUDUCHERRY AND CUSTOMS ZONE, CHENNAI.

As per Para 3.2.1 and 3.2.2 of the transfer/placement guidelines, 2018 for Group "A" Officers of the Indian Revenue Service (C&CE), the Officers will, as far as possible, be rotated between the Customs and GST branches every 2-3 years. At stations where there are separate Principal Chief Commissioners/ Chief Commissioners of Customs and GST, a Committee of all such Chief Commissioners shall collectively decide on the rotation between Customs and GST & CX Zones. Normally, this shall be done after the Annual General Transfers have been effected.

- In view of the above, a Meeting was held on 15-12-2020 at the 02. Conference Hall in the office of the Principal Chief Commissioner of GST & Central Excise Chennai between Shri. G.V. Krishna Rao, Commissioner of GST 85 Central Excise, Chennai and Shri. M.V.S. Choudary, Chief Commissioner of Customs, Chennai for rotation of Deputy/ Assistant Commissioner between Customs and GST & Central Excise Zones.
- 03. The following principles were considered for deciding the rotation of the officers.
  - a. Officers who have completed a continuous tenure of TWO years and more as on 01.11.2020 in Chennai GST Zone and Chennai Customs Zone listed out in the charts prepared and the officers with longer tenure are considered for rotation. Those officers who are working outside Chennai City whose representations for retention in the present place of posting are considered for justifiable reasons.

- b. Officers who are attaining superannuation up to June 2021 are not considered for rotation so as to ensure that there is no disruption in preparation of retirement papers of these officers.
- c. It is decided to reduce the gap between the vacancy percentage in both Zones, to the extent possible without causing operational difficulty in various formations.
- d. Officers though not falling in the above criteria but have made a request for transfer out of their present zone on justifiable grounds are considered.
- 04. Board in their Order No.123/2020 dated 02-11-2020, have transferred 03 Officers out of Chennai GST & Central Excise Zone and no officer has been posted to Chennai GST Zone. No officer has been posted in or transferred out of Chennai Customs.
- 05. As on date, sanctioned strength, working strength and vacancy position in the grade of AC/ DC in both Zones is as follows: -

06. It has been decided to transfer 19 AC/DCs from Customs Zone to GST & CX Zone and 25 AC/DCs from Chennai GST Zone to Customs Zone to reduce the gap in vacancy percentage in both the Zones. Ms.Brindha Boopathy, Deputy Commissioner, presently working in Chennai Customs Zone has requested transfer to GST & CX Zone on medical grounds. As per the principles considered for rotation in para no. 3(d) above, her request has been considered. After these transfers, the percentage of vacancy in Chennai GST Zone will be 56% and that of Chennai Customs Zone will be 57%.

07. Based on the principles mentioned in para 3 above and the discussions, it was decided to rotate/transfer Officers from GST & Central Excise Zone to Chennai Customs Zone and vice-versa as follows: -
