- 2. All representations received as on date regarding posting and transfers in the grade of Superintendent stand disposed off.
- 3. All the officers should join their new place of posting immediately and compliance reported.
- 4. The postings within the divisions shall be done by respective Jurisdictional DC /AC keeping in mind local Transfer Policy guidelines and CVC instructions.
- 5. If any postings in deviation of any of these guidelines and instructions are required to be made in view of shortage of officers or on account of number of sensitive charges is overwhelming higher than the non-sensitive charges, reasons for such deviations shall be recorded in writing in file.
- 6. It shall be ensured that no Range charge will be held on additional charge basis. However, in view of the shortage of officers Jurisdictional DC / AC are free to allocate Divisional Hqrs. charges as additional charge to Range officers.
- 7. Jurisdictional DC / AC are also advised to rotate the range officers between highly sensitive and less sensitive postings.
- 8. Jurisdictional DC / AC are also advised not to keep any sensitive charges that are critical for efficiency and effectiveness of Tax Administration and Tax Law Enforcement vacant at any given point of time.
- 9. Any difficulty in following these instructions may be brought to the notice of the Additional Commissioner (Administration).
