(b) They should have undertaken similar work for the Central/State Government for a minimum period of 10 years and should have executed at least one single order for a value of more than Rs.15 Lakhs. Work completion certificate to be enclosed to the quotation, as proof.

(c) No advance shall be paid and payment will be made only on completion of the work.

(d) The envelope containing the quotation should be super scribed as, "QUOTATION FOR SUPPLY & FIXING OF GYPSUM BOARD FALSE CEILING AND ALLIED WORKS" and should be addressed to the Joint Commissioner of GST & Central Excise, Chennai Audit II Commissionerate, Chennai 35. The quotation should be submitted in a sealed cover and should reach the undersigned on or before 06.12.2021 by 15.00 hrs.

5. The sealed quotation will be opened at 16.00 hrs on the same day. The intending firm who would be allotted the tender must be in a position to complete the work within 15 days from the date of receipt of the work order.
