The reply to your RTI application is furnished here under:

Point No. 1 : A copy of the letter in F.No: A-11019/98/89-90 Ad.IV dated 10th August 1990 has already been enclosed with this office reply C.No. II/39/104/2021-CCA.RTI dated 21.09.2021 (Point No. 9) to your RTI Application dated 23.08.2021 which underlines the functions and powers of Principal Collectors, the then Cadre Controlling Authority.

Point No. 2 : The appointment orders for the year 1992 are not available. No Direct recruit examination was conducted for 2007. As regards Appointment orders issued in the year 2019, the same is available in the website. Link is as given hereunder:

Point No. 5 : The promotion orders issued during the year 1992 are not available. The copies of promotion orders issued during the years 2007, 2016 and 2019 to the grade of Superintendents will be provided on payment of Rs. 107/- (25 A4 sheets x Rs. 2/- and 19 Legal sheets x Rs. 3/-).

Point No. 7 : The cadre Controlling Authority issues Inter Commissionerate Transfer orders during the month of May/June. Based on these orders the respective Commissioners issue further orders within the Commissionerate. Authority already given in Point No.1.

Point No. 12 : Already replied in Point No. 11.


