Reply to Point No. 1 & 5 : The minutes of the Screening Committee meeting comprises of information relating to two prosecution cases filed by CBI and Disciplinary proceedings of the Department against Shri S. Asokaraj. The charges are still pending finalization. Since the investigation against the Officer in two prosecution cases filed by the CBI are still pending and that the appeal filed against the FR 56(j) proceedings is subjudice, the report of the Screening Committee could not be provided in terms of Section 8(h) of RTI Act, 2005.

Reply to Point No. 2 & 6 : With respect to the information regarding whether the Commissioner of GST & Central Excise, Puducherry is the Appointing Authority & with respect to the information regarding the authority of Commissioner of GST & Central Excise, Puducherry Commissionerate to issue orders under Rule 56j of FRSR, it is informed that the information was already provided to you to the similar RTI application bearing Registration No. CEXCH/R/E/21/00036 dated 10.06.2021
