Text of Application	1. I am living in Chennai. My native place is Palathupatti Village, Kodumbapatty Post, Via Palakurichi, Trichy District, PIN 621 308, TAMIL NADU, where my father, Thiru M.Alagappan, is presently living. 2. During August/Sept. 2020, I installed LIVGUARD INVERTER and BATTERY at the house in my native place referred to above through one Thiru K.Prakash, Viralimalai, R.Kulavaipatti, Iluppur Taluk, Pudukkottai District PIN 621 316, TAMIL NADU. After installation and making payment to him, I insisted on handing over the Bills and the Warranty Cards pertaining to the Inverter and the Battery. Even after many phone calls to him (His mobile phone No.7092623716) and sending messages to him through WhatsApp, he never bothered to hand over the said bills and warranty cards. I, therefore, lodged a complaint dt.28.12.2020 with the Inspector of Police, Viralimalai Police Station, Pudukkottai District PIN 621 316, TAMIL NADU. 3. After enquiry with me and Thiru K.Prakash by Viralimalai Police Station and after a period of more than 3 months from the date of making complaint with the Police, I have received the records from the Sub Inspector of Police, Viralimalai Police Station, Pudukkottai District, TAMILNADU, on 23.4.2021 which were handed over by Thiru K.Prakash to Viralimalai Police Station, that too without furnishing the bill for LIVGUARD Inverter and Battery. Copies of the said records are attached. Consequently, it is ot not known whether GST was paid or not by the above person who has supplied and installed the said two items (LIVGUARD BATTERY AND UPS). Though the cost of LIVGUARD Inverter and Battery has been indicated as Rs.16,000/- in the bill attached, I have not received the bill from the above person for the same wherein the details of GST have been mentioned. In view of the above, I request you to kindly inform me the GST paid/ collected by the Government for the above two items and also the name of the Dealer who has sold the above two items in August/Sept 2020 after collecting the GST for the said items.
