This office is in receipt of several orders from the Court of Chief Commissioner of Disabilities (Divyangjan) directing the Department to consider the representations received from Physically Handicapped officers of this zone for transfer on loan basis to zones nearer to their native. It has been recommended that the Department shall review and revise the Circular dated 20.09.2018, by virtue of which blanket ban was imposed on Inter Commissionerate transfers in the cadre of Inspectors and to create an exception in matters of Inter Commissionerate Transfer for employees who are persons with Disabilities.
