Please refer to your letter No.AIASCT/CU/GC/03/2022 dated 14.03.2022 on the above subject intimating about four phase agitation programme from 16.03.2022.

02. In this connection, reference is invited to the DOPT's instructions issued vide F.No.33012/1(S)2008-Estt(B)(pt) dated 12.09.2008 which prohibits Government servants from participating in any form of strike including mass casual leave, go-slow etc or any action that abet any form of strike will be in violation of Rule 7 of the CCS(Conduct) Rules, 1964. The right to form an Association does not include any guaranteed right to strike. Going on strike is a grave misconduct under the Conduct Rules and that misconduct by the Government employees is required to be dealt with in accordance with the law. Any employee going on strike in any form will be taken serious note of and those concerned would face the consequence which beside deduction of wages, may also included appropriate disciplinary action.

03. Therefore, the action in instances of violation of discipline and conduct rules would be taken in accordance with the instructions on the subject, if it is found that members of AIASCT are found to be indulging in similar activities.
