Please refer to this office letter C.No.II/3/21/2012-CCA.Est dated 15.03.2022 on the above subject.

02. In this connection, kind reference is also drawn to Board's directions issued in their letter F.No.B-12017/03/2022-AD.IV A dated 16.03.2022 (copy enclosed) wherein it has been clearly indicated that DOPT's instructions issued vide F.No.33012/1(S)2008-Estt(B)(pt) dated 12.09.2008 prohibits Government servants from participating in any form of strike including mass casual leave, go-slow etc or any action that abet any form of strike will be in violation of Rule 7 of the CCS(Conduct) Rules, 1964. The right to form an Association does not include any guaranteed right to strike. Going on strike is a grave misconduct under the Conduct Rules and that misconduct by the Government employees is required to be dealt with in accordance with the law. Any employee going on strike in any form will be taken serious note of and those concerned would face the consequence which beside deduction of Pay and Allowances, may also include appropriate disciplinary action.

03. Therefore, it is once again reiterated that any action, in the instances of violation of discipline and conduct rules, will be taken in accordance with the instructions on the subject, if it is found that officers of this Zone are found to be indulging in similar activities.

04. This is issued with the approval of Chief Commissioner, GST & Central Excise, Tamilnadu & Puducherry Zone.

Subject: Agitation by All India Association of Superintendents -reg.

All India Association of Superintendents of Central Tax vide their letter No. AIASCT/32/CBIC/2021-dated 3.3.2022 addressed to Chairman (CBIC), has submitted a representation wherein the Association has informed about the various forms of protest to be adopted w.e.f. 16.03.2022.

2. In this connection, it may be noted that the said Association has not yet been recognized by the Board and the process of recognition is under active consideration. Therefore, participation in any form of protest by members of unrecognized Association shall be the decision of individual alone and cannot be attributed as Association's decision. Further, attention is invited to the instructions issued vide DOPT OM No 36012/01(S)/2008-Estt (B) dated 12.09.2008, which prohibits government servants from participating in any form of strike including mass casual leave, go slow etc. or any action that abet any form of strike in violation of Rule 7 of the Conduct Rules. Attention is also drawn to the social media Policy of the Government.

3. Accordingly, all CCAs may suitably counsel the officers concerned in their jurisdiction regarding the rule position, both with reference to strike or notice thereof.


MEMORANDUM
