Sub: Confirmation in the grade of Inspectors - DPC held on 03.12.2021 – Vigilance Clearance/Education Qualification/ Caste Certificate Verification -Reg

The Departmental Promotion Committee (DPC) meeting for Confirmation in the grade of Inspectors was held on 03.12.2021 and 227 Inspectors were empanelled for confirmation. However, the DPC has decided that the orders of confirmation may be issued after the fulfilment of all the conditions stipulated in the offer of appointment viz. physical test, medical examination, verification of character and antecedents, verification of original certificates regarding date of birth, educational qualifications, caste certificate, disability certificate and any other relevant documents, before issue of the confirmation orders.

- 2. The DPC has decided that although the vigilance clearance as on the date of completion of probation in respect of the 227 Inspectors has been furnished, the vigilance clearance for all the empanelled Inspectors as on date may be verified prior to issue of the Confirmation Order. It is informed that, the verification of genuineness of caste certificate and/or educational qualification is/are also pending for some officers. The pending documents to be sent to this office have been sorted out into 4 Annexures as given below:
 - a. Annexure A (120 Officers) As on date Vigilance Clearance
 - b. Annexure B (32 Officers) Verification of Educational Qualification
 - c. Annexure C (51 Officers) Verification of Caste Certificate
 - d. Annexure D (24 Officers) Verification of both Educational Qualifications and Caste Certificate.
- 3. It is for information that the Confirmation Orders for all 227 Officers shall be issued only after the receipt of pending documents as mentioned above. As on Date Vigilance Clearance of Officers as mentioned in Annexure A may be sent to this office at the earliest. The authenticated certificates of the Officers mentioned in Annexure B, C, and D (as detailed above) may be sent to this office at the earliest along with the Vigilance Clearance as on date of sending the Verification Status to this Office.
