Memorandum

This office is in cognizance of the letter for protest by All India Central Excise and Service Tax Ministerial Officers Association (AICESTMOA) dated 18.02.2022 addressed to Chairman, CBIC, which has also been tweeted on social media.

- 02. In this connection, reference is invited to the DoPT's instructions issued vide F.No.33012/1(s)/2008-Estt(B)(Pt) dated 12.09.2008 which prohibits Government servants from participating in any form of strike including mass casual leave, go-slow etc., or any action that abet any form of strike will be in violation of Rule 7 of the CCS (Conduct Rules), 1964. The right to form an Association does not include any guaranteed right to strike. Going on strike is a grave misconduct under the Conduct Rules and that misconduct by the Government employees is required to be dealt with in accordance with the law. Any employee going on strike in any form will be taken serious note of and those concerned would face the consequence which besides deduction of wages, may also include appropriate disciplinary action. In this connection attention is also drawn to the Social Media Policy of the Government.
- 03. Therefore, the action in instances of violation of discipline and conduct rules would be taken in accordance with the instructions on the subject, if it is found that members of AICESTMOA are found to be indulging in similar activities.
- 04. This is issued with the approval of the Competent Authority, Cadre Control, Tamil Nadu and Puducherry.
