Sub: Calling of willingness from Superintendents to serve in Special Economic Zone, Bargur/ Krishnagiri Region as Authorised officers – Reg.

In pursuance of the demand from the Development commissioner MEPZ-SEZ Tamil Nadu, it is proposed fill one vacancy of Authorized Officer in SEZ Bargur /Krishnagiri Region, on transfer basis based on Willingness/Seniority/APAR gradings/ Vigilance status of willing/eligible Superintendents.

- 2. All Superintendents of GST and Central Excise, Tamil Nādu & Puducherry who have not attained 56 years of age as on 31.08.2022 are eligible for being considered. However, Superintendents who had previously worked in SEZs as Authorised officer will not be considered.
- 2.1 The normal period of posting in SEZ will be two years. It is extendable by one year at the discretion of Office of MEPZ-SEZ. Officer once selected for SEZ Bargur / Krishnagiri Region will not be considered for deployment in any other SEZ. Officer selected would be liable to be repatriated before completion of their normal tenure, in case their work in SEZ is not found satisfactory and they cannot apply for any other SEZ posting in future.
- 3. It is requested that this reference may be circulated among all the Superintendents working under the respective charge.
