MINUTES OF THE MEETING OF SCREENING COMMITTEE FOR COMPASSIONATE APPOINTMENT HELD ON 18.03.2022 & 23.03.2022.

1. CONSTITUTION OF THE SCREENING COMMITTEE:

The following members of the Screening Committee constituted by the Competent Authority met on 18.03.2022 at 10.30 Hrs & 23.03.2022 at 14.00 Hrs in the Conference Hall of PCCO, Nungambakkam, Chennai – 600 034 to scrutinize the applications and recommended suitable candidates for Compassionate Appointment.

The Committee consists of the following members:

2. OBJECT OF THE SCHEME FOR COMPASSIONATE APPOINTMENT:

As per DoP&T's O.M.No.14014/02/2012-Estt.(D) dated 16.01.2013, the object of the scheme for compassionate appointment is to grant appointment on compassionate grounds to a dependent family member of a Government servant dying in harness thereby leaving his family in penury and without any means of livelihood, in order to relieve the family of the Government servant concerned from financial destitution and to help it get over the emergency.

3. IMPORTANT INSTRUCTIONS ON COMPASSIONATE APPOINTMENT:

The following are some important instructions on compassionate appointment as per the consolidated instructions circulated vide DoP&T's O.M.No.14014/02/2012-Estt(D) dated 16-01-2013 and dated 30-05-2013:



- (a) The foremost important ground for consideration of the application of the dependent of the deceased Government servant for compassionate appointment is that the family is indigent and deserves immediate assistance for relief from financial destitution [Clause 5(a)].
- (b) Applicant for compassionate appointment should be eligible and suitable for the post in all respects under the provisions of the relevant Recruitment Rules. However, upper age limit could be relaxed by the appointing authority wherever found to be necessary [Clause 6 (B) Note-II]
- (c) A married son is not considered as dependent on a Government servant. However, a married daughter can be considered for Compassionate Appointment provided she was wholly dependent on the Government servant at the time of his / her death on the condition that she must support other dependent members of the family (Q. No.12 and 13 of FAQs on Compassionate Appointment). The same has been modified as the married son is also eligible by DoP&Ts O.M. dated 25.02.2015 and 05.09.2016. Past closed cases should not be reopened.
- (d) Appointments made on grounds of compassion should be done in such a way that persons appointed to the post do have the essential educational and technical qualifications and experience required for the post consistent with the requirement of maintenance of efficiency of administration [Clause 18 (a)].
- (e) While considering a request for appointment on Compassionate grounds a balanced and objective assessment of the financial condition of the family has to be made taking into account its assets and liabilities (including the benefits received under the various Welfare schemes) and all the other relevant factors such as the presence of an earning member, size of the family, ages of the children and the essential needs of the family, etc., [Clause 18 (c)].



(f) Requests for Compassionate appointment consequent on death or retirement on medical grounds of erstwhile Group D staff may be considered with greater sympathy by applying relaxed standards depending on the facts and circumstances of the case [Clause 18 (e)].

5. ELIGIBILITY AS PER RECRUITMENT RULES:

For the post of **TAX ASSISTANT**:

Educational qualification : Degrees of a recognized University

or equivalent

Age Limit

: 20 to 27 years.

The candidates for the post of Tax Assistant will be required to possess the Skill test norms of (i) Data Entry test: 2000 key depressions in 15 minutes.



For the post of **STENOGRAPHER GRADE -II**:

: 12th Standard Pass or equivalent from a Educational qualification

recognized Board or University

Age Limit

: 18 to 27 years.

The candidates for the post of Stenographer Grade -II will be required to possess the Skill test norms of (i) Dictation: 10 minutes @ 80 words per minute. (ii) Transcription: 50 minutes (English: 65 minutes)

For the post of **HAVALDAR**:

Educational qualification : Matriculation

Age Limit

: 18 to 27 years.

The candidates for the post of Havaldar will be required to possess the prescribed physical standards and should pass physical test prescribed in the Recruitment Rules.

In case of Compassionate Appointment, the upper age limit can be relaxed by the Appointing Authority wherever found to be necessary.

6. NUMBER OF APPLICATIONS:

6.1 The Screening Committee has been informed that, as on date, 95 applications are pending for consideration for appointment under compassionate grounds. This includes applications which have earlier been rejected under the criteria of pending for more than 3 years and also under the criteria of the applicant being married son. Details of the said 95 applications are enclosed as Annexure 'A' to this minutes.

The said 95 applications for compassionate appointment have been categorized as detailed below:-

7. The committee met on 18.03.2022 and discussed the modalities to be uniformly followed while scrutinizing the applications. Since it was observed that, in the Enquiry Report in certain cases, the Basic Family Pension amount was mentioned taking into account the Dearness Relief, it was decided to seek clarification from all the Commissionerates. The Committee then decided to reconvene on 23.03.2022. The Committee again met on 23.03.2022, on receipt of clarifications and scrutinized the applications.



8. SCRUTINY OF APPLICATIONS:

8.1 Table for allocation of points to various attributes based on a 100 point scale

Central Board of Indirect taxes and Customs vide letter F.No. A.12012/52/2018-Ad.III B dated 15.05.2019 prescribed a relative merit point and revised procedure for selection of candidates for appointment under compassionate grounds. Accordingly, merit points have been allotted to each applicant for the each attributes prescribed by Board. Thus total merit points for each applicant has been arrived at.

- 8.2. The Committee examined the eligible 76 applications for compassionate appointment, along with its enclosed documents including duly filled in Part A, Part B of the application, copy of death certificate, copy of legal heir certificate, copy of educational certificate of the applicant, NOC from other family members, report on details of terminal benefits/pension per month, details of fixed/other assets, employment status of the applicant/any other dependents of the government servant, the verification report of the concerned Commissionerate, as forwarded by various Commissionerates in the Chennai Cadre Control Zone.
- 8.3 Scrutiny of the 76 applications who possess the educational qualification of matriculation and above, along with all the enclosed documents, was carried out to select the most eligible candidates by applying the merit points prescribed by the Board vide letter F.No. A.12012/52/2018-Ad.III B dated 15.05.2019.
- 8.4 The details of the 76 applicants along with the merit points are given below.
