- 2. The date of confirmation is subject to such modification as may be found necessary at a later date.
- 3. Attention is invited to Rules 18 & 19 of the CCS (Pension) rules, 1972. On confirmation of reemployed personnel, an option is necessarily to be given to the 'Head of Office' either to continue drawing
  pension from previous service and to retain gratuity for the previous service or refund them if already
  drawn. The option should be exercised within three months of the date of issue of this order and if the
  officer is on leave on the date of issue of this order, within 3 months of his return from leave. It should be
  noted that if options are not exercised within the aforesaid period, the government servant shall be deemed
  to have opted to draw the Pension/Gratuity for his past service.
