The reply to your RTI application is furnished here under:

Point No. (i) : Copy of F. No. A-11013/04/2002-ad. IV dated 31.03.2003 enclosed.

Point Nos (ii),(iii), (iv),(vi),(vii),(viii) and (ix):

1. This office has categorically informed through several letters that all appointment orders / promotion orders/ No Objection Certificates for Deputation etc are issued by the Chief Commissioner in his capacity as the Cadre Controlling authority. Once the officer joins his designated Commissionerate, his appointing authority is henceforth the Commissioner of the Commissionerate where he joins.
2. Please refer to the enclosed Board's letter in F.No.A-11013/04/2002-Ad,IV dated 31st March 2003, on the subject matter of declaration of Chief Commissioner of Central Excise/Customs as Cadre Controlling Authorities upto Group B level staff.

Para 2 of the said letter clarifies to quote

“ the Chief Commissioners of Customs/Central Excise have not been declared/notified as appointing authority/disciplinary authority in respect of staff upto Group B level in the cadres under their control. It is further clarified that the appointing/disciplinary authorities in respect of staff upto Group B level will continue to remain the same as were existing earlier. The Chief Commissioner's who were declared as cadre Controlling Authorities will, however oversee the work relating to establishment matters, recruitment, promotion, confirmation etc.”

3. Hence it is once again reiterated that once the recruitment process is

completed all further service matters of the officers are under the control of the Commissioners to where the officers are posted. Similarly matters relating to Deputation/ Inter Commissionerate transfers/promotion orders etc which form part of establishment are also under control of Chief Commissioner. Internal posting /transfers within the Commissionerate are done by the Commissioner in charge of the Commissionerates. Commissioner's are not authorized to refuse promotion/ deputation/ ICT's after the cadre Controlling authority issues orders. As such the points raised by the applicant in (vi), (vii), (viii) and (ix) have no relevance.

Point No. v) : No DPCs are convened by Commissioners to accord Promotions in the Ministerial and Executive Cadre from 2000 to 2021.

It is once again reiterated that replies to all the above queries have already been replied to / and provided by this office vide office letters C. No. II/39/94/2021-CCA-RTI dated .09.2021, C.No. II/39/95/2021-CCA.RTI dated 30.09.2021 and File No. GCCO/RTI/APP/71/2022-CCAESTT-O/oPr.CC-CGST-ZONE-CHENNAI/532835/2022 dated 17.01.2022.

If you are not satisfied with the reply, you may file an appeal within thirty days from the date of receipt of this letter, before the Appellate Authority, whose designation and address is given below:
