Sub.: Forwarding of grievance on the issue of grant of financial upgradation under MACP Scheme – Reg.

Please refer to Deputy Secretary letter F.No.A-26017/18/2021-Ad IIA dated 24.10.2021 regarding the representation of Shri.N.C.Srinivasan, Deputy Commissioner (Retd., from DGoV, SZU, Chennai) for grant of 3rd MACP on completion of 30 years of service w.e.f. 1.09.2008. In this regard, the following is informed for kind consideration.

It is seen from the above mentioned Board's letter that Shri. N C Srinivasan who joined as Inspector of Central Excise in Chennai Zone on 26.11.1974 was promoted as Assistant Commissioner (Group A Service) on 23.01.2006 and retired as Deputy Commissioner, DGoV, Chennai on 31.03.2012. He has requested for grant of 3rd MACP to the grade pay of Rs.6600/- w.e.f 01.09.2008. It has been informed vide Board's letter dated 11.05.2021 that powers had already been granted to concerned Cadre Controlling Authorities under CBIC to grant financial up gradation under MACP Scheme. However, since Shri.N.C.Srinivasan, Deputy Commissioner has retired from DGoV., the officer does not

come under the Cadre Control Authority of Chennai GST Zone. Neither the service particulars / service book, nor APAR Dossiers /vigilance status of the said officer is available with this Cadre Control Authority. Therefore, the said Board's letter had been forwarded to DGoV, Chennai vide this office letter C.No.II/39/509/2020-CFCCA dated 18.06.2021 for action at their end. Subsequently, no correspondence has been received from DGoV in this regard.

Further, in terms of Board's letter F.No.A-26017/133/2012-AdIIA dated 08.02.2017, powers have been delegated to concerned Cadre Controlling Authorities under CBIC for grant financial up gradation under MACP Scheme to officers of Group 'A' post which are not part of an organized Group 'A' service, and the recommendation of the screening committee would be placed before the concerned Chief Commissioner/ Director General for approval. Kind attention is also invited to Board's letter F.No. A-11013/10/2016-AdIV dated 11.06.2019 wherein it is stated that in respect of the Directorates, DGPM is the Cadre Control Authority (for Group B and C officers) and the work related to MACP shall be done by the individual Directorates. The MACP benefits to Group 'A' (unorganised services) officers, who had retired from this Cadre Control has already been approved and disbursed as mentioned in the representation of the individual.

In view of the above, it is informed that since this office is not the Cadre Control Authority for the officers working/ retired from Directorates (DGoV in the instant case) and that none of the particulars of the officer is available with Cadre Control Authority of Chennai Zone, this office is not in a position to carry out the instructions issued by the Board vide letters dated 11.05.2021 and 24.10.2021 to ameliorate the grievance of the individual on the issue of grant of financial up gradation under MACP scheme.
